## **Description:**

- Open to all artists over
- 18 years of age. Artwork must remain for the duration of the exhibit.
- **FEE \$10** for each number of entries, maximum 3, (NON-REFUNDABLE). If you submit 3 entries, the fee is \$25
- All entries must submit their registration form and payment by May 3<sup>rd</sup>. Fill out the form below, pay your entry fee by the Chamber's PayPal button on their website- [www.portjeffchamber.com](http://www.portjeffchamber.com), or mail in a check made out to the PJCC or stop by the Chamber; 118 W. Broadway, PJ 11777 the Chamber can accept a credit card over the phone, 631-473-1414.
- Artwork must be original, framed for display. All mediums including acrylic, oil, watercolor, pastel, photography, etchings, monoprints, mixed media, sculptures or collage are welcome.
- Size: Please submit measurements of artwork to include framing. Artwork will be matched to those businesses reflecting the size of each piece and their location at those participating businesses. Example: Their window size, shelf etc. All work must be properly presented for exhibition, wired and ready to hang or supported by an easel. If artists have easels to help display their artwork this would help logistically.
- All work must be identified. On the back of all artwork, please include artist's name, title of work, medium, price, phone/email address. **All artwork needs to be available for purchase!**
- All work must be family friendly.
- Artist agrees to allow PJCC to use images of their work in promotional materials. Artist will be credited.
- You will be notified of the location of where your artwork WILL BE DISPLAYED. Artists will take their work directly to the business at a mutually AGREEABLE TIME. Set-up needs to take place between from May 14<sup>th</sup> – 16<sup>th</sup>
- Pick Up: June 1<sup>st</sup> – 4<sup>th</sup> business hours 9-5pm.
- SUBMIT BY EMAIL OR MAIL. EMAIL ATTACHMENTS OR SEND PHOTOS TO CHAMBER. Photos will not be returned.
- The Chamber will take care of printing guides for the art walk and distribute them to those participating businesses along with having copies at the office and PJ Village Center. We will also use social media to help market this event.
