Description:

- Open to all artists over 18 years of age. Artwork must remain for the duration of the exhibit.
- The fee is **\$10** for each entry, maximum 3, (NON-REFUNDABLE). If you submit 3 entries, the **fee is \$25**.
- All entrants must submit their registration forms and payments by October 2nd.
 - Chamber's PayPal button on their website - www.portjeffchamber.com
 - Mail or bring in-person a check made out to the PJCC - 118 W. Broadway, Port Jeff, NY 11777.
 - The Chamber also accepts a credit card over the phone, 631-473-1414.
- Artwork must be original, framed for display. All mediums including acrylic, oil, watercolor, pastel, photography, etchings, monoprints, mixed media, sculptures, or collage are welcome.
- **Size:** Please submit measurements of artwork to include framing. Artwork will be matched to those businesses reflecting the size of each piece and their location at those participating businesses. Example: Their window size, shelf etc. All work must be properly presented for exhibition, wired and ready to hang or supported by an easel. Artists must supply all materials to properly display their artwork(s). The business may assist in this endeavor.
- All work must be identified. On the back of all artwork, please include artist's name, title of work, medium, price, phone/email address. **All artwork needs to be available for purchase!**
- All work must be family friendly.
- Artist agrees to allow PJCC to use images of their work in promotional materials. Artist will be credited.
- You will be notified of the location of where your artwork WILL BE DISPLAYED. Artists will take their work directly to the business at a mutually AGREEABLE TIME between the artist and store owner/manager. **Set-up will take place October 14th - 16th** OR a different time that is mutually arranged with the artist and business owner. All artwork **MUST** be displayed in a front windows.
- Pick Up: **November 2nd- 6th** during business hours 9-5pm.
- This application can be submitted via email (info@portjeffchamber.com) or by mail. Please make sure to send photos or scans of your artwork to the Chamber. Photos will not be returned.
- The Chamber will take care of printing guides for the art walk. Guides will be available at participating businesses, Chamber office and PJ Village Center. We will also use social media to help market this event as well.
